Notice Concerning Organizational and Personnel Changes

This is to provide notification that TOMY Company, Ltd. (hereinafter "Tomy") has resolved at its Board of Directors meeting held today to make the following organizational and personnel changes as of October 1, 2012.

1. Organizational changes

The organizational changes indicated below will be implemented in order to strengthen further an organizational structure in which sales growth is prioritized both in Japan and overseas. Tomy aims to achieve this by simultaneously carrying out business structure reform in terms of the two pillars of the "capability to create products" and the "capability to maximize sales of products" as current issues for achieving the targets of the medium-term business plan.

(1) Strengthening the region-based planning structure on a global level

In order to clarify the roles and responsibilities of operations in Japan and those in overseas regions and construct a speedy planning framework that has linkage with sales companies in all regions, the organization will be restructured as follows.

- a. The Japan business will be reorganized according to business category and efforts will be made to share targets for each category with sales companies in Japan.
- b. Overseas operations will be reorganized into US & Europe Business Strategy, Asia Business Strategy and the existing China Business Strategy. Development divisions will be established in each of these businesses, and efforts will be made to have them share targets with sales companies.
- (2) Strengthening the new product planning structure

In order to invigorate the creation of new plans, three new planning divisions will be established through the integration and reorganization of existing divisions, thus strengthening the structure.

(3) Strengthening of sales structure in Japan

In order to streamline business processes that are carried out both at the headquarters sales divisions and sales companies in Japan, and to strengthen a structure that promotes sales growth by unifying the sales

strategies and tactics of the headquarters with those of sales companies, sales functions in Japan will be integrated with the domestic sales company U-ACE COMPANY, LTD., and this will be transferred to TOMY MARKETING COMPANY, LTD., which will be newly established. The Sales Management Division at the headquarters will be in charge of group-wide item control and control of business division and Japanese sales company targets, and will have responsibility for each business in Japan.
