Notice Concerning Merger Among Consolidated Subsidiaries

TOMY Company, Ltd. (hereinafter "Tomy") hereby provides notification that three of its consolidated subsidiaries, the domestic functional subsidiaries TOMY BUSINESS SERVICE CO., LTD., T2 ENGINEERING CO., LTD. and TOMY KOSAN CO., LTD., have decided to merge leaving TOMY BUSINESS SERVICE CO., LTD. as the surviving company.

1. Objective of merger
